The Mopani District Municipality herein represented by Matshankutu Timothy Maake in his capacity as Municipal Manager (hereinafter referred to as the **Employer** or Supervisor)

and

Minah Ombie Mathebula, Employee of the Municipality (hereinafter referred to as the **Employee**).

WHEREBY IT IS AGREED AS FOLLOWS:

1. Ir	ntroduction	1.1	The Employer has entered into a contract of employment with the Employee in terms of section 57(1) (a) of the Local Government: Municipal Systems Act 32 of 2000 ("the Systems Act"). The Employer and the Employee are hereinafter referred to as "the Parties".
		1.2	Section 57(1)(b) of the Systems Act, read with the Contract of Employment concluded between the Parties, requires the Parties to conclude an annual Performance Agreement.
		1.3	The Parties wish to ensure that they are clear about the goals to be achieved, and secure the commitment of the Employee to a set of outcomes and outputs that will secure local government policy goals.
		1.4	The Parties wish to ensure that there is compliance with Sections 57 (4A), 57 (4B) and 57 (5) of the Systems Act.

		2.2	Specify objectives and targets defined and agreed with the Employee and to communicate to the Employee the Employer's expectations of the Employee's performance and accountabilities in alignment with the Integrated Development Plan, Service Delivery and Budget Implementation Plan (SDBIP), the Departmental Business Plans and the Budget of the municipality.
		2.3	Specify accountabilities as set out in a Performance Plan, which forms an Annexure to the Performance Agreement.
		2.4	Monitor and measure performance against set targeted outputs.
		2.5	Use the Performance Agreement as the basis for assessing whether the Employee has met the performance expectations applicable to his or her job.
		2.6 In th	e event of outstanding performance, to appropriately reward the Employee.
		2.7	Give effect to the Employer's commitment to a performance-orientated relationship with its Employee in attaining equitable and improved service delivery.
	Commencement nd duration	3.1	This Agreement will commence on the 1 July 2009 and will remain in force until 30 June 2010 thereafter a new Performance Agreement, Performance Plan and Personal Development Plan shall be concluded between the Parties for the next financial year or any portion thereof.
		3.2	The Parties will review the provisions of this Agreement during June each year. The Parties will conclude a new Performance Agreement and Performance Plan that replaces this Agreement at least once a year by not later than the beginning of the first month of the successive financial year.

- 5.4 The Employee undertakes to actively focus towards the promotion and implementation of the KPAs (including special projects relevant to the Employee's responsibilities) within the local government framework.
- 5.5 The criteria upon which the performance of the Employee shall be assessed shall consist of two components, Key Performance Areas and Core Competency Requirements, both of which shall be contained in the Performance Agreement.
 - 5.5.1 The Employee must be assessed against both components, with a weighting of 80:20 allocated to the Key Performance Areas (KPAs) and the Core Competency Requirements (CCRs) respectively.
 - 5.5.2 Each area of assessment will be weighted and will contribute a specific part to the total score.
 - 5.5.3 KPAs covering the main areas of work will account for 80% and CCRs will account for 20% of the final assessment.
- The Employee's assessment will be based on his / her performance in terms of the outputs / outcomes (performance indicators) identified as per attached Performance Plan (Annexure A), which are linked to the KPA's, and will constitute 80% of the overall assessment result as per the weightings agreed to between the Employer and Employee:

- 5.7 In the case of managers directly accountable to the Municipal Manager, key performance areas related to the functional area of the relevant manager must be subject to negotiation between the Municipal Manager and the relevant manager.
- 5.8 CCRs that are deemed to be most critical for the Employee's specific job should be selected ($\sqrt{}$) from the list below as agreed to between the Employer and Employee.

6. Evaluating Performance

- 6.1 The Performance Plan (Annexure A) to this Agreement sets out -
 - 6.1.1 The standards and procedures for evaluating the Employee's performance.
 - 6.1.2 The intervals for the evaluation of the Employee's performance.
- 6.2 Despite the establishment of agreed intervals for evaluation, the Employer may in addition review the Employee's performance at any stage while the contract of employment remains in force.
- 6.3 Personal growth and development needs identified during any performance review discussion must be documented in a Personal Development Plan as well as the actions agreed to and implementation must take place within agreed time frames as set out in the Personal Development Plan.
- The Employee's performance will be measured in terms of contributions to the strategic objectives and strategies set out in the Employer's IDP.
- 6.5 The bi-annual and annual performance appraisal will involve:
 - 6.5.1 Assessment of the achievement of results as outlined in the Performance Plan:
 - (a) Each KPA should be assessed according to the extent to which the specified standards or performance indicators have been met and with due regard to ad hoc tasks that had to be performed under the KPA.
 - (b) An indicative rating on the five-point scale should be provided for each KPA. Inclusive of KPI and project outputs, accumulatively.
 - (c) This rating should be multiplied by the weighting given to each KPI or project during the contracting process, to provide a score.
 - (c) The applicable assessment rating calculator (refer to paragraph 6.5.3 below) must then be used to add the scores and calculate a final KPA score.

6.5.2 Assessment of the CCRs

- (a) Each CCR should be assessed according to the extent to which the specified proficiency levels have been met.
- (b) An indicative rating on the five-point scale should be provided for each CCR.
- (c) This rating should be multiplied by the weighting given to each CCR during the contracting process, to provide a score.
- (d) The applicable assessment rating calculator (refer to paragraph 6.5.3) must then be used to add the scores and calculate a final CCR score.

6.5.3 Overall rating

An overall rating is calculated by using the applicable assessment-rating calculator. Such overall rating represents the outcome of the performance appraisal, capturing all relevant outcomes in the Performance Plan. An example of the Assessment rating calculator is

6.6 The assessment of the performance of the Employee will be based on the following rating scale for KPA's and CCRs:

The appraisal indicates that the Employee has achieved above fully effective results against more than half of the performance criteria and indicators and fully achieved all others throughout the year.

- 6.7 For purposes of evaluating the Annual Performance of the Director, an evaluation panel constituted of the following persons must be established -
 - 6.7.1 Municipal Manager
 - 6.7.2 Chairperson of the Performance Audit Committee
 - 6.7.3 Member of the Executive Committee
 - 6.7.4 Municipal Manager from another municipality
- The Manager responsible for Human Resources of the municipality must provide secretariat services to the evaluation panels referred to in sub-regulations (d) and (e).
- 7. Schedule for Performance Reviews

7.1 The performance of each Employee in relation to his / her Performance Agreement shall be reviewed within the month following the quarters as indicated with the understanding that reviews in the first and third quarter may be verbal if performance is satisfactory:

First quarter: July – September 2009(October 2009)Second quarter: October – December 2009(January 2010)Third quarter: January – March 2010(April 2010)Fourth quarter: April – June 2010(July 2010)

7.2 The Employer shall keep a record of the mid-year review and annual assessment meetings.

	7.3	Performance feedback shall be based on the Employer's assessment of the Employee's performance.				
	7.4	The Employer will be entitled to review and make reasonable changes to the provisions of Annexure A from time to time for operational reasons. The Employee will be fully consulted before any such change is made.				
	7.5	The Employer may amend the provisions of Annexure A whenever the Performance Management System is adopted, implemented and / or amended as the case may be. In that case the Employee will be fully consulted before any such change is made.

11. Management of Evaluation	11.1	The evaluation of the Employee's performance will form the basis for rewarding outstanding performance or correcting unacceptable performance.				
Outcomes	11.2	A performance bonus of between 5% to 14% of the all-inclusive annual remuneration package may be paid to the Employee in recognition of outstanding performance to be constituted as follows:				
		11.2.1 A score of 130% to 149% is awarded a performance bonus ranging from 5% to 9%.				
		11.2.2 A score of 150% and above is awarded a performance bonus ranging from 10% to 14%.				

- 11.2.3 Specific bonus percentages will be determined on a sliding scale, proportionately to the points scored, and rounded up to the next 0.25 percentage. e.g. 136% score = 6.678% = 6.75% bonus.
- 11.2.4 The bonus percentages for the two semesters will be calculated separately and the average of the two will determine the person's annual bonus percentage.
- 11.3 In the case of unacceptable performance, the Employer shall
 - 11.3.1 Provide systematic remedial or developmental support to assist the Employee to improve his or her performance
 - 11.3.2 After appropriate performance counselling and having provided the necessary guidance and/ or support as well as reasonable time for improvement in performance, the Employer may consider steps to terminate the contract of employment of the Employee on grounds of unfitness or incapacity to carry out his or her duties.
