Proposals sealed in an envelope clearly marked as follows: **"Provision of Consulting Engineering Professional Services for the functional improvements of existing Water Treatment Infrastructure"** and the **municipality name** should be placed in the bid box at **Mopani District Municipality, Office Number: 42, Main Road, Giyani**, not later than **12:00 on Thursday, 5 September 2013** where bids will be opened in public.

Mopani District Municipality does not bind itself to accept the lowest or any bid and reserves the right to accept the whole or part of a bid. Bids will be evaluated and adjudicated in line with Mopani District Municipality's Procurement Policy, Preferential Procurement Policy Framework Act of 2011 and the 90/10 points system will be used. The adjudication of bids will be based on functionality first. Only bidders who score more than 75% points on functionality will be assessed further on Price and BBBEE status. All bids will remain valid for a period of 90 days.

Late submissions, telegraphic, telefax, or e-mail transmission of tenders will not be accepted.
