PROJECT NAME: MOPANI DISTRICT MUNICIPALITY OFFICE BUILDING AND ACCESS ROAD - MAIN CONTRACT

Tenders are hereby invited for: Mopani District Municipality Office Building and Access Road - Building Contract, in Tzaneen, Limpopo Province. The contract consists of Building, Civil, Electrical, Mechanical and Road works.

Tender documents will be available as from **Friday 18th January 2013** at the offices of Mopani District Municipality, Office 42, 1st floor, Government Building Complex, Giyani.

Only Tenderers that have a CIDB contractor grading of **8GB** or higher are eligible to submit Tenders. Joint ventures are also eligible to submit Tenders provided every member of the Joint Venture is registered with the CIDB and a combined grade of the Joint Venture calculated in accordance with the construction industry development regulations is equal to or higher than a contractor grading of **8GB**.

Tender documents can be obtainable upon payment of non-refundable tender amount of **R350** per set of documents. **Only cash or bank guaranteed cheques made payable to Mopani District Municipality will be accepted.** No tender documents will be available at the site inspection.

A compulsory site inspection will be held on **Tuesday the 22nd January 2013** at **10h00**. Prospective tenderers are requested to meet the Engineer at the site of the **existing Mopani District Municipality Disaster Centre, Agatha Road in Extension 78, Tzaneen** and proceed to the site after the briefing.

A person who is suitably qualified to comprehend the implications of the work to be done must represent the Tenderer at the site inspection. A representative will only be allowed to represent one Tenderer.

Completed tender documents, sealed in an envelope and clearly marked: **Bid No.: MDM 2013-027 – Mopani District Municipality Office Building and Access Road** must be deposited in the tender box of Mopani District Municipality, Room 42, 1st floor, Government Building Complex, Giyani, not later than **12h00** on **Friday 15th February 2013**, when they will be opened in public.

Mopani District Municipality does not bind itself to accept the lowest or any other tender and reserves the right to accept the whole or part of a tender. Tenders will be adjudicated in line with Mopani District Municipality's Procurement Policy read with the Preferential Procurement Policy Framework Act, 2011 in consultation with the CIDB Act.
