PHALABORWA SEWAGE PUMP STATION: SUPPLY, DELIVERY, INSTALLATION & COMMISSIONING OF MECHANICAL & ELECTRICAL EQUIPMENT

Tenders are hereby invited for the construction of mechanical and electrical works for the Phalaborwa sewage pump station in the Limpopo Province. The pump station pumps the town of Phalaborwa's sewage to the wastewater treatment works approximately 5km outside of town.

This contract comprises the supply, delivery, installation and commissioning of mechanical and electrical equipment for the above pump station which includes:

- Two (one duty and one standby) new sewage pumps for pumping of raw sewage to the WWTW.
- Associated pipe work inside pump station including isolation and non-return valves.
- New valve and actuator complete with power supply on main inlet pipeline (500mm) for diverting of sewage to emergency ponds.
- New electrical and control equipment including cabling, control panels, variable speed drives, switchgear and ultrasonic level indicators.

Only bidders who are registered with the CIDB and have a grading of **5ME/4MEPE** or higher are eligible to bid for this contract.

Bid documents will be obtainable as from the **21**th **August 2012** at the offices of Mopani District Municipality, Office No: 42, 1st Floor, Main Road, Giyani upon payment of non-refundable amount **R350.00** cash.

A Compulsory Site Inspection will be conducted at **11h00** on the **24th August 2012**. Prospective bidders are expected to meet the Engineer at the pump station in Phalaborwa. Access to the site can be obtained by travelling east into Phalaborwa using the R71 from Gravelotte (Hendrik van Eck Street). Go through the town of Phalaborwa and turn right into Koper Street at the SPAR complex. The site is situated immediately on your left behind SPAR.

Completed bids and supporting documents must be sealed in a cover clearly marked "BID NO. MDM 2013 – 005A: PHALABORWA SEWAGE PUMP STATION: MECHANICAL & ELECTRICAL EQUIPMENT" and should be deposit in the bid box of Mopani District Municipality, Office No.42, 1st floor, Old Government building, Giyani, before 12h00 on the 12th September 2012 where bids will be opened in public.

Mopani District Municipality does not bind itself to accept the lowest or any bids and reserves the right to accept the whole or part of a bid. Bids will be evaluated and adjudicated in line with Mopani District Municipality's Procurement Policy in consultation to the CIDB Act and the 90/10 points system will be used. The First phase of evaluation will be on Functionality and only bidders who meet the minimum requirement on functionality will be evaluated on Price and B-BBEE Status as indicated on the bid document. All bids will remain valid for a period of ninety days after the time and date of opening.
