## MOPANI DISTRICT MUNICIPALITY STRIVES TO MAINTAIN ITS STRATEGIC POSITION AS THE FOOD BASKET OF SOUTHERN AFRICA AND TOURISM DESTINATION OF CHOICE.

Mopani District Municipality hereby call for two (02) interested persons to serve in the District Municipal Planning Tribunal for the purpose of determining land development and land use applications in terms of the Spatial Planning and Land Use Management Act, Act No. 16 of 2013.

**ATTRIBUTES:** Applicants must be persons with leadership qualities, knowledge and experience in spatial planning, land use management and any other related fields thereto.

**FIELDS OF INTERESTS:** Town and Regional Planning and Legal (Knowledge in land conveyancing will be an added advantage to any legal person).

**TERM OF OFFICE:** The appointed candidates shall serve the remaining five years' term of office left by the previous incumbents who resigned, which is ending by the 11<sup>th</sup> February 2026.

**APPLICATION CRITERIA:** The application must be a natural person and each application must be accompanied by the following details: Full names, address and identity number of the applicant, written motivation not exceeding one page by applicant on why he / she should be Mopani District Municipality member to serve in its Planning Tribunal, and A curriculum vitae of the application with certified copies of qualifications and registrations and registration certificate with recognized professional body.

**DISQUALIFICATIONS:** In terms of Section 38 of the Spatial Planning and Land Use Management Act, Act No. 16 of 2015, the following persons are prohibited to serve in the Municipal Planning Tribunal, non-citizens of RSA, member of Parliament, Legislature and Municipal Council, un-rehabilitated insolvent persons, declared mentally incompetent persons under Mental Health Care Act, Act No. 17 of 2002, former convicts involving dishonesty, persons ever removed from office of trust on account of misconduct or removed from municipal tribunal, persons found guilty of misconduct, incapacity or incompetent and other transgressions as provided for in this section of the Act.

**REMUNERATION:** Remuneration of the Municipal Planning Tribunal is in accordance with the Treasury Regulations for the remuneration of commissions and committees of inquiry and audit committee including the reimbursement of travelling expenses and other costs related to the performance of tribunal activities.

**WOMEN AND PEOPLE WITH DISABILITIES ARE ENCOURAGED TO APPLY AS THE APPOINTMENT WILL BE MADE ACCORDING TO THE COUNCIL'S EMPLOYMENT PLAN BY ENSURING REPRESENTATION OF DESIGNATED GROUP IN THE MUNICIPALITY.**
