Mopani District Municipality (MDM) hereby invites formal written price quotation from prospective accounting service providers who are registered on the central supplier database (CSD) for performing inter-municipality reconciliation for water and sanitation transactions for the 2017/18 financial year end.

MDM is the water authority and Greater Ba-Phalaborwa Municipality is the water service provider (WSP). During the year, WSP performs the following functions: Billing and Collection and recording of water and sanitation revenue. These transactions are maintained and accounted for by WSP in their financial systems. MDM seeks an accounting service provider who will verify and reconcile all water and sanitation transaction for accuracy for the purpose of reporting in the annual financial statements of both MDM and WSP.

### Scope/responsibility of service provider

- Verification of water and sanitation financial data at the municipality.
- Resolve prior year audit finding relating to water and sanitation transactions.
- Calculations of provision for impairment and compiling journals.
- Reconcile all general ledger accounts that needs to be transferred to MDM and recommend adjusting journals.
- Assist the MDM to verify and process all required journal entries proposed by WSP.
- Obtain and file signed off confirmation of balance from WSP.
- Assist in obtaining accurate and complete supporting documents for all water and sanitation transactions from WSP.
- Assist in handling any water and sanitation related finding by Auditor General prior to and during audit process.
- Provide on the job training and skills transfer to MDM personnel dealing with water and sanitation revenue management.
- Quality control and data integrity checklist.
- Compiling and audit file with approved reconciliations and verified supporting documents.

**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
  - a. Take all reasonable steps to prevent such abuse;
  - b. Reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
  - c. Cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
- 5 In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

<sup>2</sup> Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

  - (c) Provides the same goods and services as the bidder and/or is in the same line of business as the bidder
6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium<sup>3</sup> will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
  - (a) Prices;
  - (b) Geographical area where product or service will be rendered (market allocation)
  - (c) Methods, factors or formulas used to calculate prices;
  - (d) The intention or decision to submit or not to submit, a bid;
  - (e) The submission of a bid which does not meet the specifications and conditions of the bid; or
  - (f) Bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
