This Erratum seeks to correct aspects of previously advertised vacant positions published on the website of the Mopani District Municipality ([www.mopani.gov.za](http://www.mopani.gov.za)), the Facebook page of the municipality on **01 December 2021**, and print media (City Press and Mopani News), while at the same time extending the closing date for submission of applications from **21<sup>st</sup> December 2021** to **14<sup>th</sup> January 2022**. Furthermore, errors in the advertisement of the following advertised vacant positions in the same advert are hereby corrected as follows:

**Directorate – Community Services.**

**Post: 2 X Operators – Emergency Communication Centre (PL. 7)** - the correct name of the post is **“Supervisor: Emergency Communication Centre”** and the number of relevant years of experience required is **“2 to 3 years”** and not 4 to 5 years as previously advertised.

**Post: 4 X Operators - Emergency Communication Centre (PL. 8)**- the number of relevant years of experience required is **“1 to 2 years”** with a **Certificate or Diploma**.

**Directorate - Water Services**

**Post: Senior Administrator (PL 7) – “Successful candidate to be stationed in Phalaborwa”, and that “knowledge of water and sanitation legislative framework”** as previously listed in the advert is **not a requirement**.

**Post: 14 X Plant / Scheme Superintendent – the post is at level 7 (Remuneration: R360 823.73 – R396 911.92) and not post level 9 (Remuneration: R256 871.97 – R295 920.82) as previously advertised.**

**Post: 2 X Chief Maintenance Superintendent - the post is at Level 5 (Remuneration: R462 193.22 – R510 469.01) and not post level 6 (Remuneration: R408 375.13 – R450 919.43) as previously advertised.**

**Post: 5 X Artisan Fitter (PL 10)** - the advertised position is now withdrawn from the advert and no applications will be processed or received further.

**Directorate - Technical Services**

**4 X Administrator / Data Capturer / Technician Assistant - the correct post name is “Data Capturer” (PL. 8) and its remuneration is R318 688.80 – R351 943.35 and not “Administrator / Data Capturer / Technician Assistant” (PL. 7) (Remuneration: R360 823.73 – R396 911.92) as previously advertised.**
