### **CALL FOR APPLICATIONS FROM INTERESTED MEMBERS OF THE PUBLIC TO SERVE IN THE MOPANI DISTRICT MUNICIPAL PLANNING TRIBUNAL**

Mopani District Municipality hereby call for **Five (5)** interested people to serve in the Mopani District Municipal Planning Tribunal for the purpose of determining Land Use and Land Development Applications in terms of Spatial Planning and Land Use Management Act, Act 16 of 2013 and the related Municipal Bylaws thereto.

**ATTRIBUTES:** Applicants must be people with leadership qualities, knowledge and experience in Spatial Planning, Land Use Management, Land Conveyancing, Engineering Services, Environmental Management and any other related fields thereto.

**FIELDS OF INTEREST:** Town and Regional Planning, Environmental Management, Legal, Water Engineering, Transport Engineering and Land Surveying.

**TERM OF OFFICE:** The term of office is five (5) years from the date of appointment publication in the Provincial Gazette by Mopani District Municipality.

**APPLICATION CRITERIA:** The applicant must be a natural person and each application must be accompanied by:

- Curriculum vitae of the applicant with certified copies of qualifications and professional body registration certificates (where applicable).
- Written motivation of the applicant which does not exceed one page on why she/he should be appointed to serve in the Municipal Planning Tribunal.

**DISQUALIFICATIONS:** Section 38 of Spatial Planning and Land Use Management Act, Act 16 of 2013 prohibits the following persons to serve in the Municipal Planning Tribunal:

- Non-Citizens or non-permanent residents of Republic of South Africa
- Members of Parliament, Provincial Legislature, Municipal Council and House of Traditional Leaders
- Unrehabilitated insolvents
- Mentally incompetent people declared or detained by court of law
- Convicts of dishonesty offence
- People removed from office of trust on misconduct
- People removed from Planning Tribunal for breach of the act
- Has been found guilty of misconduct, incapacity or incompetence
- Failed to comply with the Act or Provincial Legislation

**REMUNERATION:** Remuneration shall be in accordance with Treasury Regulations on the remuneration of committee members of enquiry category B sub-category B1 including reimbursement of travelling expenses and other expenses related to the performance of tribunal activities.

**WOMEN, YOUTH AND PEOPLE WITH DISABILITIES ARE ENCOURAGED TO APPLY AS THE APPOINTMENT WILL BE MADE ACCORDING TO THE COUNCIL'S EMPLOYMENT EQUITY PLAN BY ENSURING REPRESENTATION OF DESIGNATED GROUP IN THE MUNICIPALITY.**
